

TERMS & CONDITIONS

1. The promoter of this competition is Cliona's Foundation
2. The competition is open to the children in Primary School in the Island of Ireland only & between the ages of 4 – 13 years
3. There will be 3 age categories 4 – 7, 8 – 10 & 11 – 13years
4. Entry into the competition can only be achieved by the method listed below:
Children should

 - Draw an image with their favourite figure included which shows this treatment of what happens when they are being looked after
